

# Construction information on Chesapeake Bay Foundation's Brock Environmental Center.

CBF's Brock Environmental Center is a planned 10,000-square foot environmental facility at Pleasure House Point focusing on promoting preservation, sustainability, and education. Brock Environmental Center is targeting LEED Platinum and Living Building Challenge certifications, which will make the center the most environmentally sustainable building in Virginia.

The center will provide:

- A "net zero" impact on the surrounding environment;
- State-of-the-art energy and water-saving features;
- An international model for green design and construction;
- A home for CBF's award-winning outdoor environmental education programs in Hampton Roads, which provide hands-on, on-the-water experiences for thousands of teachers, students, citizens, and community leaders annually;
- Active demonstrations of important restoration projects;
- Office space for the Chesapeake Bay Foundation, Lynnhaven River NOW, and other conservation groups;
- Public meeting spaces for conservation dialogue and training.

With all aspects of the project meeting the strictest of environmental standards, CBF believes the Brock Environmental Center will engage, inform, and inspire the Hampton Roads community to solve the Bay's challenges in innovative, sustainable, and collaborative ways.

Construction will begin soon:

- August 1 -- installation of construction fencing and project signage.
- August 15 (approximate) -- actual construction of the building begins.
- All construction traffic will travel on Stratford Road and Shore Drive. Construction vehicles will park at the pump station parking lot.
- The public will also be able to park at the pump station for the majority of the construction period.
- There will be access changes to the City of Virginia Beach trails near the construction site. Information on trail changes will be posted on signage.
- The building is scheduled to open Summer/Fall 2014.
