A year from this month, artist Donald Lipiski hopes to install his sculpture, The Canoes, at the pedestrian outlook on the southwest side of the new Lesner Bridge. The sculpture will be 26 feet wide and 36 feet tall and illuminated with LED lights from within the filigreed canoes.

The canoe motif was an historic nod to the origin of the Lynnhaven Inlet, Lipiski, told the Bayfront Advisory Commission. Adam Keeling cut a trench from his property to access the Chesapeake Bay by canoe. Subsequent storms created today's inlet over which the new bridge spans.

The \$350,000 project will be privately funded through donations to the Public Art Virginia Beach Foundation, said Andrew Fine, Foundation chairman. Although \$260,000 of that has been pledged through large donations, the Foundation and BAC hope that the Bayfront community will continue to support the art for the city's signature bridge. "It is important that this community participate," Kal Kassir, BAC chairman said, "whether it is through bake sales or civic leagues or just chipping in."

ampton Roads Transit and the City of Virginia Beach have greenlighted the Bayfront-to-Oceanfront-to Bayfront shuttle! It will start May 21 and run every 45 minutes from 8.m. to midnight through Labor Day and will continue weekends through the Neptune Festival.

The shuttle is a trial program designed to allow locals and visitors to transit the Bayfront, First Landing State Park, the North End and Oceanfront without having to worry about parking or driving while impaired,

Route 35 will run between Vista Circle on the east side of the Lesner Bridge and 19th Street along Shore Drive.

Reminder: gantry move to close Shore Drive

The enormous yellow gantry that has been parked on the north side of the new Lesner Bridge will be moved to the south sometime in the next few weeks, Christopher J. Wojtowicz told *Baylines*. At some point, the entire bridge will be closed, but this will be done between midnight and 4 a.m. on one or more days to minimize traffic disruption.

One the falsework pipes at the new site are finished, girders will be placed across the new bridge. The gantry will then be winched across Shore Drive from north to south and put into position to begin erecting the superstructure of the new eastbound bridge.

Specific information will be made public when dates and times are set. Motorists should check electronic signs as the date(s) approach for up-to-the-minute information.
