- 1) Gave Power Point presentation regarding results of city funded Sea Level Rise study worked on with Dewberry Consultants Policy Adaptation Report

- 3) Many possible solutions including sea gate at the Lesner Bridge
- 4) VB costs for flooding losses today, \$12 million annually, with a 1.5' rise, it would be \$50M, a 3' rise would cost \$271M
- 5) Federal contribution will be 50% and State contribution may be 25% of total cost
- 6) There will be public input meetings in May 2019, presentation to City Council in August, and then presentation to public of final plan after that

- 3) 4th of July Fireworks Councilman Wood is asking the City Manager to have city pay for Bayfront fireworks, might be able to have them in 2019, or if too late for budget, might have to wait until 2020.
