Minutes from September meeting were approved. Wally Damon moved to approve (with correction, website link added), Empsy Munden seconded.

Vice President Report: Empsy Munden reports 1) At the VBCCO meeting, Deputy City Manager Kenneth Chandler spoke. Empsy talked to him regarding the speed limit of 35 mph on Shore Drive, the possibility of a traffic light at Kendall and Shore Drive, citing accidents and near-misses, and also the possibility of a traffic light at Lynnhaven Drive and Great Neck Road, with new development at Marina Shores area. 2) Mark Johnson of VB Public Works was at the Sept BAC meeting.

Treasurer's Report: Treasurer Tim Solanic reported \$7558.05 in operating fund, \$1549.55 in special fund, with \$46 spent on PO Box.

President's Report:

Old Business:

- 1) **Rt 35 Bayfront to Oceanfront Shuttle:** Rt 35 survey will be on SDCC website. There is some concern that the stretch of First Landing Park with no stops (ridership) could hurt the figures the city looks at to justify the route.
- 2) **Tidal Sluice Gates near Citrus and Food Lion** have had their automatic operations fixed. Todd may ask a Public Works representative to speak at the February SDCC meeting regarding sea level rise.
- 3) **Electric Scooters:** City Council held an informal briefing October 15 to discuss escooters and would like to have regulations in place by the end of 2019.
- 4) **Ocean Park Beach Sand Replenishment:** The city is soliciting bids and work should begin early 2020.

New Business:

- 1) **Bonaventure/Windsong Apartment Development:** Scheduled to appear before Planning Department Wed, December 11, at noon. Chesapeake Beach still is in opposition as to density and traffic issues.
- 2) **Shore Drive Improvements Phase 3 – Great Neck to Lesner Bridge:** Public Works Director, Mark Johnson, says this has been delayed and is now scheduled to start Spring 2021.
- 3) **Lake Bradford/Chubb Lake Stormwater Improvement Meeting:** City Public Works will hold this informational meeting at the Bayside Recreation Center on Thursday, November 14, from 6 – 7:30 pm.

Community Concerns:

- 1) Whatever happened with the 2 homes scheduled to be built on Shore Drive at Marlin Bay Drive across from the 7-11? Apparently, they were approved but no building has begun.
- 2) **Neighborhood Watch:** Empsy Munden reports that the VBPD has certain requirements to designate a Neighborhood Watch area/neighborhood. She says that the effort might be handled on Nextdoor.com.
- 3) **VB Comprehensive Plan survey now available online** at <https://www.publicinput.com/VBCompPlan>. Citizens are encouraged to complete the survey. Website indicates survey will only be available through November 27, 2019.
