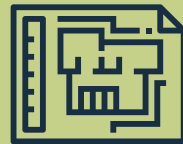
Bayfront Advisory Commission (The BAC)

The mission of the BAC is to review and make recommendations to the City Council regarding public and private projects and issues associated with the Bayfront area, and projects or issues associated with the Bayfront area that the City Council may refer to the Commission.



Communications Committee

The Communications Committee is in tasked with general outreach to the Bayfront community. Examples of such outreach includes: the maintenance of email lists with area civic league representatives and other interested parties, newsletters, etc.



Design Committee

Originally charged with updating the Shore Drive Corridor Guidelines, the current primary role of the Design Committee is to review and make recommendations to the full Commission regarding design issues with development applications.



Executive Committee

The Executive Committee includes the BAC Chair and Vice-Chair. The Committee handles official correspondence with groups outside the Commission, including an annual meeting with the City Council liaisons and City Manager about BAC priorities.



Transportation & Public Safety Committee

Formerly referred to as the Transit, Parking, and Pedestrian Access Committee, this Committee includes a fourth component of safety which has arisen in recent discussions, in addition to the Committee's work on a variety of transportation concerns.

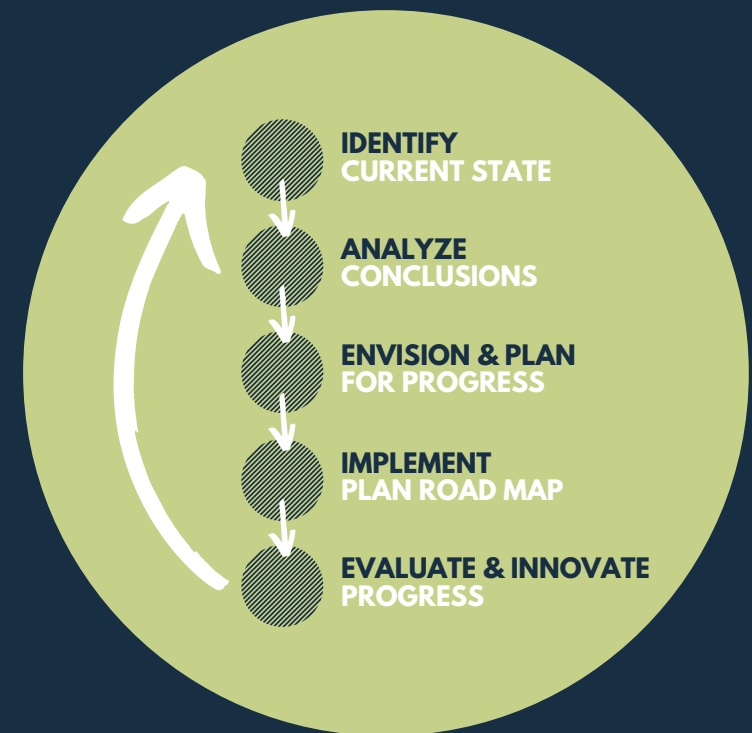
