CALL TO ORDER:

Chair Lindemann called the meeting to order at 3:30 P.M.

ROLL CALL:

Hank Morrison did roll call.

MOTION TO APPROVE THE MINUTES FROM 9/18/25 MEETINGS:

Motion by Bill Hearst, seconded by Morgan Ayers. The meeting minutes were approved unanimously.

CHAIR'S REPORT and INTRODUCTIONS:

 Chair Lindemann asked whether the commission was amenable to providing the meeting packet digitally versus paper copies.

STAFF REPORTS

- Public Works: Mrs. Shannon provided an update on the Pleasure House Point Project including the plating process, the prior weather event, and concerns about flooding in the Ocean Park neighborhood. Additionally, an update was provided on beach replenishment projects on the east and west side of the Lesnar Bridge including the Cape Henry Beach Replenishment Project. An update was provided on the lighting on the Lesnar Bridge.
 - Mr. Amorosso asked about when the surveys of the beaches for beach renourishment projects would take place.
 - Mr. Cohen asked about replenishment and replanting of the Ocean Park Beach as well as the use of improved quality sand.
- Planning: Mr. Morrison provided a presentation on the draft 2040 Comprehensive Plan specifically the Coastal Context Area.
 - Mr. Bovee asked whether Mr. Morrison received a list of questions created by the Infrastructure Committee.
 - Mr. Prince asked about the height called for in the local center in the Coastal Section.
 - Councilmember Schulman discussed areas that could be focused on such as the area around Bayville and Greenwell Road.
 - Councilmember Cummings discussed the state requirements regarding a Comprehensive Plan and the purpose of a Comprehensive Plan.
- Chair Lindemann asked for a motion to move the presentations up to the next item on the agenda. The motion was made by Morgan Ayers and seconded by Joe Bovee. The motion was unanimously approved.

PRESENTATIONS/DISCUSSIONS

- 1) Single-Use Plastic Bag Fee Presentation Karen Forget and Dylan Mason with Lynnhaven River Now discussed a 5 cent tax on single-use plastic bag fee.
 - a. Mr. Cohen asked what other localities are doing in place of plastic bags.
 - b. Mrs. Forget specified that the tax would be specific to grocery stores, drug stores, and convenience stores.
 - c. Mr. Prince asked about the impact of the tax on littering.
 - d. Chair Lindemann asked if the desire was for the Bayfront Advisory Commission to provide a letter of support for the proposal.
 - e. Mr. Cohen asked whether LynnhavenRiver Now whether they were working in other cities or just in Virginia Beach.
 - f. A member of the public asked if it would apply to box stores with grocery sections.

- g. Councilmember Cummings stated his concern for the financial impact of the tax on low income individuals and communities.
- h. Councilmember Schulman encouraged that the plan be shared with the public for review.
- i. Mr. Cohen asked whether the tax had to be 5 cents or if it could be lower.
- j. Mr. Prince asked whether plastic bags could be banned.
- 2) Prosper Home & Investments, LLC Tyler Rosa representing the application for a Subdivision Variance for Prosper Home & Investments, LLC. Mr. Rosa provided an overview of the proposal which is for a two lot subdivision.
 - a. Mr. Cohen asked about the need for a subdivision variance.
 - b. Mr. Bovee asked about the height of the proposed homes.
 - c. Commissioner Coston asked whether an existing single-family would be torn down for the development.
 - d. Mr. Davenport asked why they were not seeking to close the paper street.
 - e. Councilmember Schulman commended the applicant for working with the Civic League to address concerns.
 - f. A member of the public asked whether the properties would be addressed for Beaufort or Bradpointe.
 - g. A member of the public asked about the square footage and the number of stories on the home.
 - h. Mr. Prince asked about the style of the proposed homes in comparison to the neighborhood.
 - i. Chair Lindemann asked for a motion. Mr. Cohen made a motion to recommend approval of the application which was second by Mr. Davenport. The motion was approved unanimously.

COMMITTEE REPORTS

- COMMUNICATIONS AND OUTREACH COMMITTEE Mrs. Ayers discussed the use of marquis to start a sign war amongst Shore Drive businesses. Additionally, she discussed the creation of Shore Drive Business directory and the creation of a logo for the BBC.
- DESIGN & PROJECT OUTLOOK COMMITTEE Mr. Bovee stated that they discussed the projects on Greenwell Road and the Prosper Home
- INFRASTRUCTURE COMMITTEE Mr. Cohen discussed ongoing discussions regarding a sidewalk audit between Marlin Bay and Shore Drive. Additionally, a discussion took place about discussion with city regarding the installation of a four-way stop sign at Fentress and Lookout.

- Councilmember Schulman discussed that he is working with Public Works and Traffic Engineering to determine areas that pose a safety concern and can be addressed with safety measures that could include sidewalks.
- STUDENT COMMITTEE Mrs. Ayers stated that they are working to set a time for all the students to meet.
- LYNNHAVEN BOAT RAMP COMMITEE Mrs. Crutchfield provided a presentation on the recommendation from the Lynnhaven Boat Ramp Committee.
 - Mr. Hearst asked about complaints brought up at prior meetings regarding the use of the Lynnhaven Boat Ramp for parties.
 - Councilmember Schulman stated that the flock cameras have been installed.
 - Chair Lindemann asked whether the recommendations were that all commercial operations be prohibited or only bareboat charters.
 - Chair Lindemann asked about the quantity of boat ramps in the municipalities that have prohibited commercial operations from boat ramps.
 - Councilmember Cummings asked about reference to rentals of personal watercraft vehicles as well as the inclusion of a requirement that individuals have boating licenses.
 - Mr. Cohen discussed concern with commercial operations utilizing a public boat launch.
 - Chair Lindemann stated that a vote would not take place today to allow the commissioners to ask questions and think about the recommendations ahead of a vote at the November meeting.
 - Councilmember Schulman stated that he was waiting for a legal opinion from the
 City Attorney's Office as to what can legally be done.
 - Mr. Amorosso asked whether the impact of changes to the Lynnhaven Boat Ramp on other sites had been reviewed.
 - Mr. Davenport asked whether other bodies had been consulted, including Beaches and Waterways Commission.
 - Mr. Prince stated that a change in operating style was needed to address issues with the Lynnhaven Boat Ramp.

PUBLIC COMMENTS

• A member of the public expressed concern with a lack of focus to the impact on people who utilize the Lynnhaven Boat Ramp for non-motorized recreational vehicles.

- A member of the public suggested utilizing the Department of Vehicles to identify boats and owners.
- A member of the public suggested that it be required that individuals be required to have a certified captain's license and documented insurance.
- A member of the public asked whether a study has been done on the revenue that has been generated from commercial operations out of the Lynnhaven Boat Ramp.
- A member of the public discussed a concern with a stormwater drain by Ships Watch Court and Whaler Court.
- A member of the public asked the commission to consider the capacity of the waterways.
- A member of the public recommended that loading be limited to 10 minutes, and Staff be empowered to enforce the policy.
- A member of the public discussed the importance of safety and a lack of safety
- A member of the public asked about whether the recommendations where to ban charter boats or bareboat charters.
- A member of the public asked to verify the number of parking spaces at the Lynnhaven Boat Ramp

Subject: House Bill 534 (Chapter 1022) & Senate Bill 11 (Chapter 1023) Article 12 - Disposable Plastic Bag Tax

Dear Mayor Dyer and Members of City Council:

At our meeting on November 20, 2025, the Bayfront Advisory Commission (BAC) voted to support the adoption of an ordinance in accordance with HB 534 and SB 11, as passed by the 2020 Virginia General Assembly, which authorizes any county or city to adopt, by ordinance, the Virginia Disposable Plastic Bag Tax on single-use plastic bags provided to customers in grocery stores, convenience stores, and drugstores.

Adopting the Disposable Plastic Bag Tax would bring significant benefits to the Bayfront and our City at large. It will help preserve the Bayfront scenic beaches and the City of Virginia Beach tourist destinations and enhance the overall experience for both residents and visitors. Cleaner shorelines and waterways are more visually appealing and protect our coastal ecosystem, an asset that draws millions of guests every year.

By enacting this ordinance, we will reduce plastic litter and enhance the City's reputation as a premier, eco-friendly resort destination and signals a strong commitment to sustainability, a growing important factor for today's environmentally conscious travelers. And, as the tax revenue is reinvested in litter control and the provision of reusable bags for those in need, the Bayfront area and our entire city will benefit from community-focused initiatives that ensure its continued economic vitality.

We ask City Council members to continue making our environment a priority and demonstrate leadership in Hampton Roads by adopting a disposable plastic bag tax ordinance in Virginia Beach.
