**CALL TO ORDER:**

Chair Lindemann called the meeting to order at 3:30 P.M.

**ROLL CALL:**

Alexis Bailey did roll call.

**MOTION TO APPROVE THE MINUTES FROM 1/15/26 MEETING:**

Motion by Ed Amorosso, seconded by Joe Bovee. The meeting minutes were approved unanimously.

**CHAIR’S REPORT and INTRODUCTIONS:**

- There was no Chair’s Report or introductions.

**STAFF REPORTS**

- Public Works: Mrs. Bailey provided the updates on Mrs. Shannon’s absence which included the Lesner Bridge lights, storm drain outfall pipe near Whaler Court, Rookery

Way beach access maintenance, beach plants – west side of the Lesner Bridge, and Shore Drive safety analysis – west side of Lesner Bridge.

- Chair Lindemann introduced Jim White to provide a presentation on the Bay Beaches Survey.
  - Mr. Cohen asked if the same species of grass was replanted as what died and if so, do they know why the initial grass died.
  - Mr. Davenport asked whether a similar survey was carried out on the east side of the Lesner Bridge.
  - Mr. Trower asked about the Rookery Way Beach Access maintenance and the rebuilding of dunes.
  - A member of the public asked about a berm constructed parallel to Rookery Way would be an option.
- Chair Lindemann introduced Jason Wilson and Kevin Quigley to provide a presentation on Shore Drive Phase III. Mr. Quigley provided an overview of the project, what's being done in the current phase, and what is next.
  - Mr. Cohen asked about the installation of new stormwater pipes and asked about the ability to keep the right lane open.
  - Councilmember Schulman expressed his thanks for Mr. Quigley and his team for the update.
  - Mr. Trower expressed his thanks for the milling and paving done.
  - A member of the public asked about the lifespan of the polymer used in the liner and the possibility to lower the speed limit using flashers to prevent speeding.
  - A member of the public asked about a sign asking people to zipper and pedestrian detour signage.
  - A member of the public asked about changes in lane closure times.
- Planning: Mr. Morrison provided an update on Route 35 and on the 2040 Comprehensive Plan.

## COMMITTEE REPORTS

- COMMUNICATIONS AND OUTREACH COMMITTEE – Mrs. Crutchfield stated the committee is discussing another opportunity to bring together bayfront business.
- DESIGN & PROJECT OUTLOOK COMMITTEE – Mr. Bovee discussed the presentation received regarding the Marlin Bay Drive Condominium project and the design guideline.
- INFRASTRUCTURE COMMITTEE – Mr. Cohen said there was no committee report.
- STUDENT COMMITTEE – The student committee did not meet.

- LYNNHAVEN BOAT RAMP COMMITTEE – Mrs. Crutchfield discussed the revised LBRC recommendations.
  - Councilmember Schulman asked to differ the recommendations to allow time for staff review and response.

## OLD BUSINESS

- There was no old business.

## NEW BUSINESS

- Shore Drive Corridor Plan & Design Guideline Topic Breakdown – Identify Core Values – Chair Lindemann asked each of the members to give a 30 second elevator pitch for the Bayfront.

## PRESENTATIONS/DISCUSSIONS

- 1) Marlin Bay Drive – Chair Lindemann introduced Mark Rosenfield to provide a presentation on the Marlin Bay Drive project. Mr. Rosenfield provided an overview of the project including the proposed rezoning, the number of units, and the site design.
  - a. Mr. Cohen asked the decision to request to conditionally rezone the site to Conditional B-4 and whether it would allow for greater density.
  - b. Mr. Prince asked about the height of the building compared to other buildings on Shore Drive.
  - c. A member of the public asked about the outdoor lighting proposed.
  - d. A member of the public asked about the height of the building, impact to the Shore Drive Corridor, and impact to the ecosystem.
- 2) Outer Banks Beach Buggies, LLC – Chair Lindemann introduced Eddie Bourdon to provide a presentation on the Conditional Use Permit for Motor Vehicle Sales and Rentals (Low-Speed Vehicles) for Outer Banks Beach Buggies, LLC. Mr. Bourdon provided an overview of the project including the layout of the site and the operation of the proposed business.
  - a. Mr. Trower asked about landscaping proposed and whether any lighting is proposed.
  - b. Mr. Bovee asked about whether any pavement is proposed to be added.
  - c. Mr. Cohen asked about why a Conditional Use Permit is required for the use.
  - d. Chair Lindemann stated concerns with the type of vehicle proposed and stated her opposition to the request.
  - e. Cole Trower made a motion to recommend approval the request which was seconded by Ed Amorosso. The motion was approved 6 to 1.

## PUBLIC COMMENTS

- A member of the public about information for illegal charters operating.
- A member of the public stated that today was the 23 year anniversary of the idea to preserve Pleasure House Point.
- A member of the public thanked Mr. Morrison and Councilmember Schulman regarding Route 35 and encouraged, if possible, advertised for Sail 250.
- A member of the public discussed the increase in density for the Marlin Bay Drive proposal.

There being no further business, the meeting was adjourned at 5:45 P.M.
